<p><b>CLAUSE 7 - DELEGATES MEETING</b></p> <p><b>(7) Elections Committee</b></p> <p>The Council shall, at its first meeting appoint an Elections Committee of five (5) members who are neither members of Council nor of Branch Committee for the purpose of conducting elections and to look into complaints regarding nominations, manifestos and elections of the principal office bearers and to make the necessary recommendations to Council. Council shall also appoint a Chairman and a Secretary from amongst these five (5) members.</p> <p>The Election Committee will be autonomous and be responsible for preparing the terms of reference for conduct of the elections.</p> <p><b>(10) Eligibility for Nomination</b></p> <p>(vii) If there are fewer nominations received for any post than there are vacancies, the Election Committee shall declare the nominees for that post elected. The Election Committee shall also inform members on the Electoral Roll that nomination and election for the remaining vacancies will be conducted at the Annual General Meeting.
