



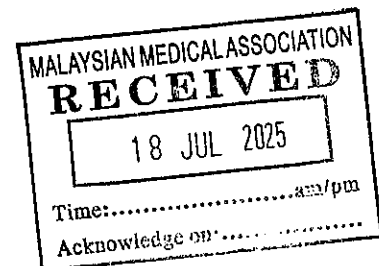

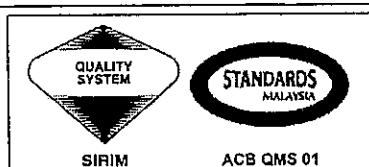
### **CLARIFICATION ON THE DURATION OF INFUSION AND PROLONG INFUSION OF CYTOTOXIC THERAPY.**

With kind reference to the above matter.

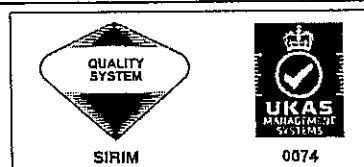
2. We understand that the 13<sup>th</sup> Schedule does not mention regarding the duration for infusion and prolong infusion of cytotoxic therapy. This has cause different opinions or suggestion regarding the duration of infusion and prolong infusion of cytotoxic therapy among the relevant medical professional bodies, insurance companies and benchmarks.

3. Based on discussion with representative from Malaysian Oncological Society of Malaysia, Malaysian Society of Haematology and taking current practice of cytotoxic therapy administration, we like to make the recommendation that:

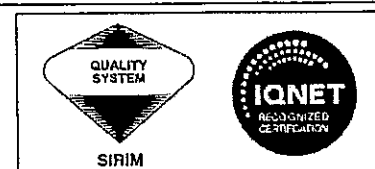
3.1 Infusion includes cytotoxic therapy given as a slow intravenous bolus;

- 3.2. Prolong infusion includes cytotoxic therapy given intravenously through an extended drip or infusion pump.

**This recommendation is only applicable exclusively for cytotoxic therapy.**
