

1. Welcome address by PPSMMA Chairman (2021/2022)

1.1 The Chairman, Dr Balachandran Krishnan thanked the members for their presence. The meeting commenced as soon as the Honorary Secretary, Dr Gunalan Palari mentioned that the quorum has been achieved. He introduced the PPSMMA Exco 2021/2022 to all PPSMMA members.

2. To confirm minutes from the previous PPSMMA Annual General Meeting

2.1 The members went through the minutes of the previous PPSMMA AGM. The Honorary Secretary enquired if the attendees had to raise any questions pertaining to the minutes. The Honorary Secretary briefed that there were many activities conducted by the PPSMMA for this term and the members have been updated accordingly.

3. To adopt the Annual Report for the year preceding

3.1 The Honorary Secretary invited the Chairman to highlight the activities done by the PPSMMA for 2021/2022 term. The Chairman mentioned that the 2021/2022 term was challenging as we initially conducted virtual meetings. He mentioned that the PPSMMA Exco & NWC members have worked together as a team with a good support from the MMA Exco. He thanked the MMA Exco and the MMA secretariat for the help and support rendered. He informed that during the 2021/2022 term, the PPSMMA had attended 96 meetings. The Chairman highlighted several activities by the PPSMMA were carried out such as the joined CSR activities with the MMA Volunteer Corps Committee (Voc), MMA Dinner Forum With Specialists' Association, sports activities and blood donation drive. He mentioned that the PPSMMA will continue to engage with MMA members and non – members through various platforms to address issues faced by medical fraternity. The Chairman once again thanked all members for their support. Then the Honorary Secretary went on to present the Annual Report.

3.2 *Fee Schedule for General Practitioners*

The Honorary Secretary read the fee schedule during the Annual Report. The Chairman invited the Honorary General Secretary (HGS) to update on the fee schedule. The HGS briefed that the Minister of Health is aware about the deregulation and the current government agrees with the deregulation. The HGS said that the MMA has suggested that the amount of RM30 – RM125 and it is divided into 3 categories which are categorised as simple, intermediate and complex cases. Unfortunately due to the change in government after the PRU 14 the decision on this matter is still unclear. In current discussions, we were informed on the rates of RM30 – RM125 is based on the negotiations that we had in the year 2017 - 2019 with Bank Negara and Statistic's department according to consumer price index(CMI). The HGS updated that at the moment the fee is RM10 –

RM35. Dr Ashok enquired on the purpose of the range of figures if were to have a deregulation. The HGS explained that the deregulation is decided by the previous government. The current government policy is on the deregulation policy and there is a split on the opinion with regards to the deregulations.

Dr Ganabaskaran suggested to write in to the Minister of Health, Yb Khairy Jamaluddin on this issue. He emphasized that we should focus on the fees schedule issue. The Chairman informed that our main agenda is the fees schedule and the current Minister of Health is actively engaged with MMA as compared with the previous one.

Dr Namazie enquired our stand on white paper. The Chairman invited the MMA President to comment on the stand on white paper. The President informed that he has been appointed into the advisory council of the white paper which consists of 13 members. He informed that the Ministry of Health expected to table the white paper during the upcoming parliamentary session. The advisory members are responsible to push forward the agenda in the white paper and manage the stakeholders.

The Chairman later invited the HGS to give his opinion on the white paper. The HGS informed that the Perikatan Nasional government has established the McKinsey's report when he served in the steering committee. He updated that the report has already been completed and it covers the issues on human resources, public and private engagement, the governance of the hospital, the governance structure of the entire healthcare system and to strengthen the primary care. The HGS mentioned that he disagreed with Datuk Dr Ganabaskaran's earlier statement on we should make a stand either to support the regulation or deregulation. He informed that in order to make a decision, MMA should make a general polling with the GP clinics instead of deciding on our own. The PPSMMA Vice Chairman, Dr John Teo mentioned that MMA did not request for the deregulation and it is the government who make that decision. He also mentioned that it is time for MMA to get the consensus.

3.3 *Managed Care Organisation (MCO) / Third Party Administrators (TPA)*

Dr Mahendran Markandoo enquired on the mechanism that we want to introduce for the MCO/TPA. The Chairman went on to invite the HGS to explain further. The HGS informed that the reason the Chairman continuously invited him is due to the continuation of the work from the past by the HGS during his chairmanship for PPSMMA. He elaborated that the MCO is not regulated in this country and we do not have the Act and regulations to monitor their practises . The HGS also informed that there were two issues which are the practice of medicine and the business of medicine. In the practice of medicine, it is compulsory for the medical doctor to comply with all the

ethical issues. As for the business of medicine, MMA is trying to engage the TPA's. The HGS informed that since the last 4 years there were a lot of engagements with regards to MCO & TPAs issues. As of now, there will be another stakeholders engagement in October 2022 where we will be looking forward for a positive outcome.

Dr N P Krishnan stated that if we have fee schedule with minimum consultation fees, then we have nothing to fight for. The Chairman informed that the most important thing is the MOH must regulate the TPA's & MCO because once it become regulated, we will have common contracts supervised by the MOH to confirm whether it follows the PHFA's policy. Besides that, all parties involved must agree with the MOH's decision.

3.4 *Fee Schedule*

The Honorary Secretary informed that for the specialist, the fees are part of the 13th Schedule. Due to that, the TPA/MCO are not pushing them around as compared to general practice. He also informed that currently they are updating the current specialist Fee Schedule. He went on to invite Dr Namazie to give his views on this matter. Dr Namazie informed that on 2013, the 13th Fees Schedule 2013 for Specialist was revised. But the 7th Schedule which governs the general practice was not revised. Dr Namazie informed that nowadays the specialist have to wait for a long time to get approval of procedures.

3.5 *Enhancing GP Practice*

The Chairman mentioned that every month, there are 500 new clinic applications and we have 35,000 contract doctors who are still floating. Due to that the parallel pathway programme will help the GP to enhance themselves by becoming Specialist. The Chairman also updated that the PPSMMA is currently in the discussion on terms with University Malaya (UM) with regards to certify a few courses for the GP's.

Dr Mahendran Markandoo enquired if we have the data from ProtectHealth Corporation with regards to Skim Peduli Sihat. He also said that he would like to know further details on GP enhancement project. Dr Selvarajah Sathaya supported the idea of collaborating with UM. He also enquired whether there will be a collaboration with Academy of Family Physicians of Malaysia (AFPM). The Chairman informed that the point by Dr Mahendran Markandoo is well noted and went on to invite the HGS to explain further on the issues with AFPM. The HGS refused to comment on the AFPM issue and went on to emphasize that the idea of working with UM is due to government planning on training the GP's to become Specialist.

3.6 *Public Private Partnership*

Dr Mahendran Markandoo enquired if we were aware that there are 3 companies screening for the private university. He informed that there is a decrease in the number of foreign students due to

the Covid19 pandemic. The HGS informed that the matter has been discussed in the previous PPSMMA AGM. He elaborated that the we have had a meeting with Education Malaysia Global Services (EMGS). He requested the members to refer to the previous minutes for further details.

Datuk Dr Ganabaskaran emphasized that the most important thing to discuss is to inform the government to outsource the Non-Communicable Diseases (NCDs) to the private clinic. The Chairman informed that the Klinik Kesihatan (KK) is overwhelmed by the public and the PPSMMA would like to suggest to shift the burden of the KK towards the private clinic on matters pertaining to health screening check-ups. Datuk Dr Ganabaskaran informed that the matter has been in practice. However, the Chairman elaborated that there are still several departments under government that required the employment check up by the KK. Datuk Dr Ganabaskaran mentioned that he is aware with the work that has been done by the PPSMMA but he suggested that if we were to propose issues in the white paper, we should propose with the NCDs matter. The Chairman informed that he is not aware on what we proposed in the white paper. He went on explaining that there are 6 million population under the B40 category that we need to tackle for the Peka B40 programme. There are 8300 GP has panel with ProtectHealth Corporation. However as of today, not even 15% of the Peka B40 programme has been utilised.

The Chairman informed that the main issue on this matter was the patient's location and how the GP could engage with these patients. The Health Minister has updated that the best way to approach the patients was via MySejahtera apps whereby several features will be updated in the apps. The Chairman informed that the GP's also need to make their own research on how to approach and engage with the B40 patients.

Dr Mahendran Markandoo pointed out that the Peka B40 is a failure because the person in charge from ProtectHealth Corporation doesn't has the knowledge of the GP issues. He complained on the lengthy procedure of the programme and suggested to revamp this programme and the Chairman must communicate this matter with ProtectHealth Corporation. The Chairman mentioned that he fully understood the sentiments and informed that they have had a meeting with ProtectHealth Corporation to simplify the procedure.

3.7 *Grievance Mechanism Committee*

The Honorary Secretary informed that the Grievance Mechanism Committee started when the specialists informed that the TPA/MCO are interfering with many clinical decision's. As a result, we created the committee to voice out the issues in a respectful manner. The committee consists of the Life Insurance Association of Malaysia (LIAM), General Insurance Association of Malaysia (PIAM), Malaysian Takaful Association (MTA), Association of the Private Hospital of Malaysia

(APHM) and regulatory body as observers which consists of Bank Negara Malaysia (BNM) and Bahagian Amalan Perubatan (Ministry of Health). The parties have reached an agreement to the terms to formalise the Grievance Mechanism Committee. As of now the committee only is able to have the meeting virtually and they are planning to have the first physical meeting in October 2022. Despite that, there are many positive outcomes which have been achieved during the meeting. Dr Gunalan also updated that we have also brought in certain issues such as the claims that were not approved for cases such as lumps and bumps and lipomas . We have also focused on the issues pertaining to audit procedure whereby there are certain procedures which are considered as inappropriate. Dr Gunalan informed that if there are any issues, members can raise it to PPSMMA and it will be brought up to the committee.

Dr Namazie mentioned that there are certain specialists were being audited by the insurance company and it was found that the specialists were involved in overcharging, unnecessary multiple coding and inappropriate charges for emergency for many years. As a result, the hospital were considered as overcharging and they were asked to payback to the insurance company. Dr Namazie also informed that nowadays many insurance companies will opt for Artificial Intelligence to scrutinize the bills.

Dr Ashok asked if there is any appeal or recourse. Dr Gunalan informed that unfortunately certain pre authorisation for procedures were being made or fabricated just to make the claims passed. If it become a series of claims by the surgeon or the hospital, then it will become an issue. The Honorary Secretary added that if the doctors found that it's a wrong act, they can lodge a report to Malaysian Medical Council (MMC) to defend their action.

Dr Mahendran Markandoo informed that MMA had proposed the Common Contract which tailored for the doctors and GP's and would like to know whether there is prospective and retrospective audit on the agreement. He suggested the MMA to make sure the agreement's terms and conditions are fair for the doctors and Bank Negara should audit the agreement. The Chairman informed that the point have been noted.

3.8 *Other matters*

Datuk Dr Ganasbaskaran suggested instead of reading the entire Annual Report, it is better to go through and let the members to point out which area that they would like to ask further. Datuk Dr Athimulam highlighted on the MMA Flood Relief Programme and thanked the efforts by PPSMMA on the programme where funds were dispersed towards affected GP clinics despite their membership status. He went on to ask whether non-MMA members who received the funds did register as the MMA member.

Datuk Dr Ganasbaskaran mentioned that it is a good effort by MMA to reach the GP clinics who were affected by the floods despite their membership status. However, he highlighted that doctors are not under the B40 or M40 group. He informed that we should provide help for those who really need the help. He also disagreed to disperse the fund towards non-MMA members.

The Honorary General Secretary came forward and informed that we should not take any questions as it has been written in the constitution that the members need to write in before the event. He informed that this is not the place where the members go through each points and discuss. As for the flood donation drive, he explained that it is a public fund raised through the MMA Foundation and the members are aware of it. Dr Mahendran Markandoo disagreed with the Honorary General Secretary's view on take up the questions during the meeting. He informed that MMA should always entertain the members and there should be a transmission of information during the meeting.

Dr Mahendran Markandoo went on suggesting that since the MMC has make it compulsory to have the 20 CPD points, MMA should make it as a conduit to increase the MMA membership.

The Honorary Secretary updated that the survey results on perception of doctors towards the insurance industry have been published on Berita MMA. As a quick summary, he informed that we received 10% of the response rate from the PPSMMA members. Majority of members responded that there are challenges to interact with the insurance company and the doctors.

Dr Ashok informed that he supported the Honorary General Secretary's view where members should submit his queries in writing to the PPSMMA Honorary Secretary not less than 7 days before the PPS AGM. He requested the Chairman to be firm on this matter.

7th FEE SCHEDULE

Since Apr 2018, the amendments to the 7th Schedule were still undergoing a process of Regulatory Impact Analysis (RIA) which will then be reviewed by the Malaysian Productivity Corporation (MPC) and further obtain the Minister of MOH's approval for the amendment draft before sending it to the Attorney General Chambers of Malaysia (Jabatan Peguam Negara) to be gazetted. This issue was kept pending and no decision was made by MOH until now. Following that, MMA has decided to get a legal opinion from a lawyer. Legal opinion was sought and according to the lawyer, court action will likely not change anything significant as such it was best to continue negotiations with MOH. Even if there is an attempt to address this in court, it would be a lengthy and complicated process that may not be in MMA's favor as well.

MANAGED CARE ORGANISATION/ THIRD PARTY ADMISTRATORS

MMA was invited to attend the MCO/TPA workshop co-organized by the Ministry of Health (MOH) and Ministry of Investment, Trade, and Industry (MITI) on 9th May 2023 at Menara MITI to discuss in detail on current updates of MCO/TPA issues and further suggest the solutions. This issue also has been discussed at the Private Healthcare Productivity Nexus (PHPN) level as part of the initiative under the Regulatory Reforms Working Group. A study on *Pelan Tindakan Sektor Perkhidmatan (SSB) 2021-2025* suggested that this challenging issue has to be look into and necessary action must be taken in order to sustain growth of the healthcare sector.

FOMEMA

Several meetings were held with FOMEMA within this term to discuss the critical radiographer shortage in the private healthcare facilities, GP's fee revision and FOMEMA biometric system. FOMEMA has previously brought up the acute radiographer shortage issue with Bahagian Kawalselia Radiasi Perubatan (BKRK, MOH) and subsequently, a virtual meeting was held to, and it was highlighted to MMA that major cause was due to the low wage offered for radiographer in private healthcare. GP's fee for the x-ray services in private healthcare is suggested to be increased from RM 25 to RM 40. Fomema's concessionaire is approaching the end of this year. MMA has held several meetings to strategize an appropriate payout for GPs who have provided their services as consultants and for X-ray services. We have prepared a specific number and are awaiting engagement with the Ministry of Health (MOH) to strengthen our demand, as the fees have not been reviewed in the past 25 years. We are hopeful for a positive outcome by the end of this year.

iHEED

The ongoing collaboration with iHEED has been successful so far. Multiple short certificate workshops have been conducted to enhance the knowledge of GPs. These workshops cover various topics such as intraarticular injection training, ultrasound, wound care, and more.

ROYAL COLLEGE OF SURGEONS, LONDON

In light of enhancing general practitioners (GPs), PPSMMA held meetings with several academies within the country and abroad. One of the collaborations is with the University of Malaya, with plans to offer various micro credentialing courses. These courses would allow GPs to accumulate points which can later be converted into diploma or degree courses. The aim is to empower GPs to provide additional services within their clinic premises. Additionally, PPSMMA is engaging with the Royal College of Surgeons in London to develop diploma courses specifically designed for GPs. These courses will be financially viable and structured to accommodate GPs' working hours.

PUBLIC-PRIVATE PARTNERSHIP (PPP) SKIM PERUBATAN MADANI - PILOT

The Health Screening Program (HSP) 3.0, a project under the PERKESO Public Private Partnership (PPP), has been launched in collaboration with governmental organizations (GOs) within the country. The objective of the program is to screen 2.2 million subscribers aged 40 and above before the end of this year. This initiative presents a significant opportunity for general practitioners (GPs). PPSMMA closely collaborates with PERKESO in implementing strategies to encourage general practitioners (GPs) across the country to provide services either at their clinics or through outreach programs to eligible subscribers. This collaborative effort aims to assist in achieving PERKESO's objectives.

PPSMMA SUB-COMMITTEE: GRIEVANCE MECHANISM COMMITTEE (GMC)

After numerous meetings between the Life Insurance Association of Malaysia, General Insurance Association of Malaysia, Malaysian Takaful Association, Association of Private Hospitals Malaysia as well as the regulators such as Bank Negara Malaysia and Ministry of Health Malaysia, an agreement was reached to formalize a Grievance Mechanism Committee comprising the above stakeholders. 4 representatives from the Malaysian Medical Association will work together with the other stakeholders to ensure that the working relationship between doctors and the insurance industry remains as harmonious as possible.

PPSMMA SUB-COMMITTEE: LEGAL TASK FORCE COMMITTEE

The new PPSMMA subcommittee was formed due to concern voiced by doctors on how medico legal act can affect their practice and there is an increasing number of medico legal cases. The committee is planning to organize an educational forum at state level targeting the junior doctors and focusing on the importance of proper documentation and patient consent to reduce lawsuits for medico legal act. The committee also planned to co-organize a roadshow with PPSMMA and SCHOMOS aiming to educate doctors on the impact of medico legal act and to reduce legal lawsuits.

2) PPSMMA ACTIVITIES 2022/2023

BLOOD DONATION DRIVE

The PPSMMA has again successfully organized Blood Donation Drive nationwide in April and May 2023. Each PPSMMA state took part in the program, and we have received good feedback from the donors. There are 8 MMA branches that took part which are W.P. Kuala Lumpur, Sabah, Sarawak, Kedah, Negeri Sembilan, Penang and Pahang.

GP LANDSCAPE SURVEY

The first study on GP Landscape Survey was carried out by MMA & Universiti Putra Malaysia (UPM) in 2017 aiming to understand the landscape of GP services in Malaysia specially in the context of Health Economics (revenues, fees & expenditures), role of MMA as a platform to serve the public. A virtual meeting was held between PPSMMA Exco, MMA National Exco & Dr Arvinderjit Singh (Medical Researcher) in April 2023 to review the questionnaire before it can be circulated to all GPs.
