This SGM is being convened by the 65th Council in accordance with Clause 7(12)(i)(a) of the MMA Constitution, which states:

"A Special General Meeting of the Association shall be convened by the Council at any time for any special reason. The Special General Meeting shall be convened by any one of the following means: physical, virtual or a combination of both."

The purpose of this SGM is to discuss and approve the following resolution submitted by the MMA Wilayah Persekutuan (WP) Branch.
