MMA Committees

A Need for Balanced Implementation

There is a pressing need to address escalating healthcare costs and MMA supports efforts to establish effective cost-containment systems. One

of the suggestions that has been put forward by the Government recently has been the Diagnosis-Related Group (DRG) system for charging. This has aroused much discussion amongst specialist in the private sector.

For MMA, this has to be approached with a thorough understanding of Malaysia's healthcare ecosystem and careful stakeholder engagement to ensure uncompromised patient care and a system that is equitable and sustainable.

Unintended consequences that may arise must be carefully considered in developing a Malaysian-specific DRG to avoid similar pitfalls as in countries where it is practised. Private healthcare facilities also vary widely in their resources and capabilities and hence a one-size-fits-all DRG system may not be the best solution.

MMA had asked that comprehensive engagements with all stakeholders, including healthcare providers, regulators, and representatives from the public and private sectors be held before implementing the DRG system. An interactive session has been held by KKM and we await further details on the resulting decisions.

A collaborative approach is essential to developing a context-specific framework that is fair, incentivizes quality care, and addresses the realities of modern medical practice. It is MMA's view that ultimately, all cost-containment measures being considered must align with the overarching goals of quality and accessibility in healthcare.

There are many other issues ongoing to write on but due to constraint of space, I will do so next month. As the month comes to an end, all are gearing up for the Chinese New Year holidays. On behalf of MMA, I wish all those celebrating a Happy Chinese New Year and Kung Hei Fatt Choy!
