BACKGROUND

- HSP was first introduced by PERKESO since 2013 to offer FREE health screening for early detection of NCDs among workers.
- In 2022, SOCSO has launched SEHATi as a new platform for HSP
 - SEHATi Mobile application for SOCSO Insured Person
 - ◆ SEHATi Portal for HSP Panels use
- More than 600,000 workers have undergone HSP from 2013 to 2022.





OBJECTIVES

- Initiate health screening awareness among workers
- Early detection of non-communicable diseases
- Prevention of disability and early death due to non-communicable diseases
- Promote healthy lifestyle and awareness of the non-communicable diseases



HSP 3.0

- According to the 2023 budget, PERKESO has received matching grant from the Government to empower health screening among workers post COVID-19.
- Therefore, HSP version 3.0 (HSP 3.0) is introduced to offer **new and enhanced health screening** initiative for the workers.
- HSP 3.0 will be implemented starting from 16th May 2023 until 31st December 2023.

HSP 3.0

- The third version of HSP offers better health screening initiatives for the workers and allows them to obtain their latest health status especially after COVID-19 pandemic.
- Re-offer FREE health screening to all eligible workers including those who has underwent previous HSP.
- According to PERKESO statistic, more than **2.2 million workers are eligible** for HSP 3.0
- New parameters are added into HSP 3.0 for early detection of more NCDs risk factors.

WHO IS ELIGIBLE?

- Malaysian
- Age 40 to 59 years old
- Actively contributed to SOCSO Contributed to SOCSO at least one (1) month in current year under Invalidity Scheme
- Contributed to SOCSO at least 12 months under the Invalidity scheme Eligible for one-time health screening

FREQUENT ASKED QUESTIONS

1. What is the duration of HSP 3.0?

HSP 3.0 is offered starting from 16th May 2023 until 31st December 2023. Therefore, all eligible employees are encouraged to undergo health screening under HSP 3.0.

2. Is the employee still eligible for HSP 3.0, if he/she has undergone HSP previously?

HSP 3.0 is a free health screening which is made available to all eligible employees including those who have undergone health screening under HSP since 2013 up to 30th April 2023; provided he/she must fulfill all HSP 3.0 eligibility criterias.

3. Does the existing HSP Panel need to register a new panel for HSP 3.0?


The existing/registered HSP Panels Clinic are not required to make a new panel registration for HSP 3.0. All registered HSP Panel Clinics will automatically become HSP Panels for HSP 3.0 effective 16th May 2023.





- Temporary set up for health screening at workplace
- Easy access for employees to undergo health screening
- Employees do not need to be present at the clinic for health screening
- Time saving
- Encourage all eligible employees to undergo health screening
- Non-eligible employees can undergo health screening using paid package offered under HSP (optional)



















PROMOTE HSP AMONG PATIENTS

Promote HSP among clinics' regular patients

proactively check patient eligibility and send promotion to eligible patient via email or SMS to patient

OPPORTUNISTIC SCREENING

To implement opportunistic screening among visiting patients

- to check HSP3.0 eligibility among visiting patient during registration
- to promote HSP3.0 to eligible patient and convince them to undergo health screening
