


With kind reference to the above matter and your letter dated 12th December 2019 regarding charges for procedures which are not stipulated in the 13th Schedule. Private Healthcare Facilities and Services (Private Hospitals and Other Private Healthcare Facilities) (Amendment) Order 2013 for the purpose of reimbursement.

Based on the discussion and recommendation from National Heart Association (NHA), National Advisor of Cardiology, Ministry of Health Malaysia and appropriate benchmarking taking into consideration the complexity and the risk of the procedures, we would like to make the following recommendations:

NO	PROCEDURE	RECOMMENDED MAXIMUM CHARGEABLE FEE FOR SURGEON	RECOMMENDED MAXIMUM CHARGEABLE FEE FOR ANAESTHETIST
1.	Invasive Imaging with intravascular ultrasound (IVUS) or intracardiac echo (ICE) or optical coherence tomography (OCT) performed in one or more vessels/cardiac chambers during diagnostic evaluation and/or therapeutic intervention. Procedure includes technical insertion of device, imaging acquisition and interpretation.	RM1340	RM 505
