

REVISION FOR CODES FOR ACUTE STROKE THROMBOLYSIS SERVICES

With kind reference to the above matter and your letter dated 14th October 2024 requesting the release of revision codes for acute stroke critical care services which are not available in the 13th Schedule for the purpose of reimbursement.

- 2. We take note that the codes for acute stroke thrombolysis services which was released in 2020 has raised several enquiries from the insurance companies and has made payment reimbursement process to medical practitioners very challenging especially the usage of two separate codes.
- 3. Based on appropriate benchmark and discussion with Malaysian Society of Neurosciences, we would like to make the following recommendation:

No.	PROCEDURE	SURGEON FEE
1.	Initial hyperacute and critical care for stroke, for the hyperacute assessment (i.e. attended within time window for consideration of reperfusion therapy, i.e. intravenous thrombolysis and/or endovascular thrombectomy) and management of patients with acute stroke, without administration of intravenous thrombolytic therapy or thrombectomy, inclusive of consultation, for a period of up to 3 hours	RM1500
2.	Initial hyperacute and critical care for stroke, for the hyperacute assessment (i.e. attended within time window for consideration of reperfusion therapy, i.e. intravenous
